Statement of Facts	The Defendant was backing up in the parking garage at Sandia Casino & Resort when the back of his Nissan Pathfinder bumped the front of Plaintiffs' car. Plaintiff Amber Eaton alleged neck and upper back sprain/strain injuries. Plaintiff Jason Jenkins alleged a low back sprain/strain. Amber Eaton's medical bills totaled \$5,513.18. Jason Jenkins' medical bills totaled \$3,172.21. Both Plaintiffs treated at Victoria Medical Center, LLC. Defendant stipulated to liability before trial. The jury rendered a defense verdict following a two day trial.

Comments	This case was on appeal from court-annexed arbitration. The arbitrator awarded the Plaintiffs the total sum of over \$17,100.
Experts	Brett Davis, D.C. with Victoria Medical Center, LLC testified for Plaintiffs. Defendants called biomechanical expert, Joseph Peles, Ph.D. from Tempe, AZ to testify live at trial.

Style Cenen Romero, Individually and as Personal Representative of the Estate of Diana Florentino and as next friend of

Destiny Florentino, a Minor Child v New Mexico Department of Transportation CV-2012-05165

Statement of Facts Cenen Romero, as mother and grandmother sought wrongful death and consortium damages for estate,

granddaughter and herself claiming the lack of a guardrail caused the death of 22 year old Diana Florentino arising from a one car MVA at MP 111 on northbound I-25 between Elephant Butte and San Antonio. The decedent's 2004 Hyundai ran off the roadway, over the shoulder,off the road and down an embankment, rolling over multiple times causing the ejection of the decedent. P's expert Joe Ruiz, as a former NMDOT highway engineer, testified the department owed a duty to conduct a pre-accident study at MP 111 due to the steep slope, and to install a guard rail which, had it been installed, would have deflected the Hyundai back onto the roadway which in turn would have saved her life. P's introduced multiple photographs of Diana with her daughter and mother in a prayer for sympathy

The defense introduced evidence of decedent's intoxication, her loss of control of the vehicle and excessive speed.
